



## State Director-The Wisconsin Partnership

Milwaukee Succeeds is a broad-based, community collaboration focused on improving educational outcomes for every child, in every school, from cradle-to-career.

The Wisconsin Partnership is a statewide coalition of four cradle-to-career partnerships including Achieve Brown County, Building Our Future in Kenosha County, Higher Expectations for Racine County, and Milwaukee Succeeds. Collectively, this coalition aligns their local partnerships to a shared policy agenda focused on datadriven, community-led policy change.

#### Purpose & Objectives

**You can make a difference, as we are seeking a State Director!** The State Director - The Wisconsin Partnership is responsible for leading both The Wisconsin Partnership and the Greater Milwaukee Foundation's education policy portfolio. This position interfaces with state, local, and federal public officials and grassroots organizations that advocate for systems-level changes to education systems from cradle-to-career.

This role collaborates across the four communities of the Wisconsin Partnership to set a shared vision, goals, and strategies; manage coalition finances, programs, and projects; draft and steward the policy advocacy and implementation processes; develop and implement the coalition's strategic plan; and engage with other advocates and stakeholders in communities from across Wisconsin.

#### **Essential Duties & Responsibilities**

- Lead the Wisconsin Partnership including implementing and managing its strategic planning, project management, and budgets.
- Lead Wisconsin Partnership advocacy efforts and manage relationships with policymakers, stakeholders, and lobbying firms.
- Build the capacity of each member community within the Wisconsin Partnership to leverage policy advocacy as a tool for systems-change.
- Convene and coordinate staff across four communities to advance coalition goals, including on community engagement, data, and communications.
- Collaborate on policy research, data analysis, and the creation of communication and advocacy materials.
- Cultivate relationships with current funder (Strive Together) to align efforts with national best practices within the Strive Together National Network as well as long-term funding opportunities from Strive Together.
- Collaborate with colleagues to build a long-term resource development plan for the WI Partnership.

- Represent the Partnership and GMF in local, state, and national policy arenas.
- Support the development of the Policy and Research Department, including staffing, budgeting, and policy agenda alignment.
- Collaborate with the Vice President of Policy and Research on GMF's education policy agenda and ensure integration with broader systems-change efforts across the foundation and community.
- Monitor and communicate education policy trends and implications for GMF and Wisconsin Partnership work.
